Sir,

This has reference to your online proposal No. IA/AP/CRZ/213336/2021, received in this Ministry seeking amendment in the CRZ Clearance issued *vide* this Ministry's letter dated 17th October, 2013 on the above mentioned proposal, in accordance with the provisions of the Coastal Regulation Zone (CRZ) Notification, 2011 issued under the Environment (Protection) Act, 1986.


2. Your request was considered by the EAC(CRZ) in its meeting held on 22/06/2021, wherein the Committee agreed that the request of M/s EIPL for amendment in the increase in the size of the pipeline from 10" to 14" diameter of POL pipeline may be carried out.

3. Based on the recommendation of EAC(CRZ), it is to inform that the following amendment shall be made in the aforesaid CRZ clearance issued *vide* this Ministry's letter of even no., dated 17/10/2013, as follows:

a. Para No. 2 shall be revised as under:

"It is inter-alia noted that the proposal is for setting up the Port based World Class facility for receipt, storage and handling of POL products and LPG. The proposal involves laying one additional pipeline of 14" and 5.315 km length to transport POL....."


4. All other terms and conditions stipulated in the CRZ clearance dated 17th October, 2013 shall remain unchanged.
